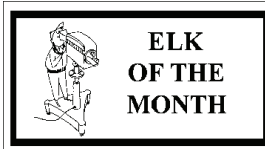

Change to Read:

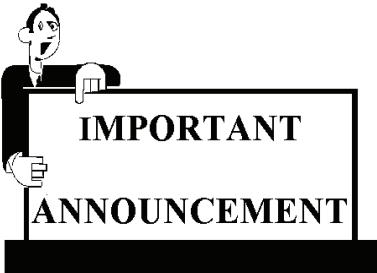
